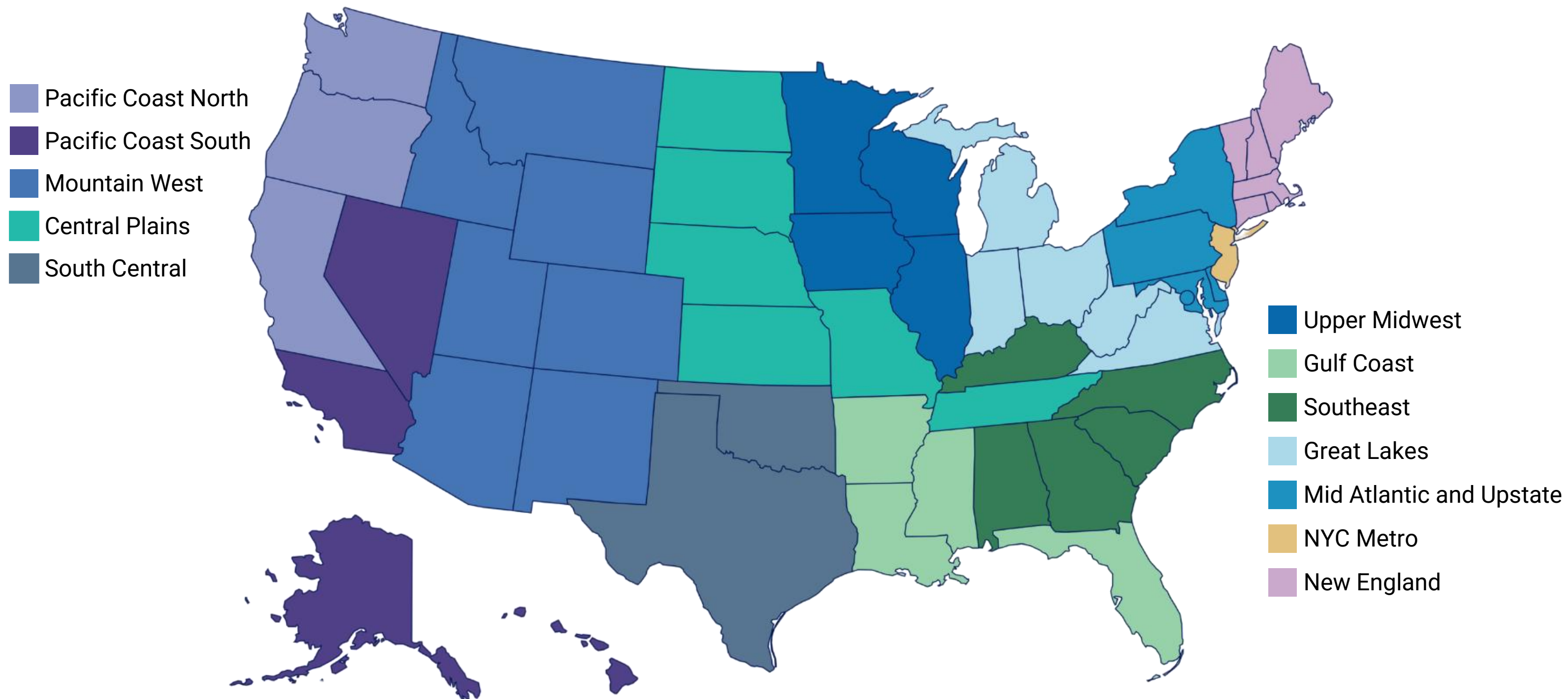


Sales Territory Map
